Why Do You Need My Information?

We use the pupil data:

- to support pupil learning
- to monitor and report on pupil progress
- to provide appropriate pastoral care
- to assess the quality of our services
- to comply with the law regarding data sharing
- to monitor pupil behaviour

The categories of pupil information that we collect, hold and share include:

- Personal information (such as name, unique pupil number and address, contact and emergency telephone numbers, contact details for persons allowed to collect pupils)
- Characteristics (such as ethnicity, language, nationality, country of birth and free school meal eligibility)
- Attendance information (such as sessions attended, number of absences and absence reasons)
- School dinner information
- Assessment information
- Exclusions/behavioural information
- Relevant medical information
- Special educational needs / health information
- Safeguarding information

What Allows You To Use My Information?

We collect and process pupil information as part of our public functions under both the Data Protection Act and Article 6, part (e) of the General Data Protection Regulation.

Who Will My Information Be Shared With?

We routinely share pupil information with:

- schools that the pupils attend after leaving us
- our local authority
- the Department for Education (DfE)
- school health
- safeguarding teams

We are required by law, to provide information about our pupils to the Department for Education as part of statutory data collections, such as the school census and early years' census. Some of this information is then stored in the National Pupil Database.

The Department for Education may share information about our pupils from the National Pupil Database with third parties who promote the education or well-being of children in England by:

- conducting research or analysis
- producing statistics
- providing information, advice or guidance

To be granted access to pupil information, organisations must comply with strict terms and conditions covering the confidentiality and handling of the data, security arrangements and retention and use of the data in compliance with the General Data Protection Regulation.

Do I Have To Provide This Information And What Will Happen If I Don't?

The majority of pupil information you provide to us is mandatory as part of our public functions under both the Data Protection Act and Article 6, part (e) of the General Data Protection Regulation, when we collect data outside of this, we will rely on your consent to collect and store your personal data.

How Long Will You Keep This Data For And Why?

We hold pupil data for

- the length of time that the pupil remains at St Mary & St Paul's
- unless
- Statute requires the school to retain the information for a longer period of time (by limitation period)
- The pupil leaves and is educated at home - (25 years)

How Will My Information Be Stored?

The information will be stored in a number of secure locations –

All personal information is kept locked away and only accessed by the appropriate staff who require it. There are a number of lockable rooms and cupboards around the school building where the data is secured.

Any data which is stored electronically is held on encrypted and password protected laptops or pen drives. Laptops are not left unsecured around the building and access cannot be gained by any other persons.

Pupil progress data is held by outside agencies (data processors) and we have full GDPR agreements in place with them.

Some data (assessment data) is held internally and for assessment tracking and progress measures. Other data has to be submitted to the Local Authority or Department for Education.

- object to processing of personal data that is likely to cause, or is causing, damage or distress
- prevent processing for the purpose of direct marketing
- object to decisions being taken by automated means
- in certain circumstances, have inaccurate personal data rectified, blocked, erased or destroyed.
