<u>Terms of Reference – Behaviour, Attitudes and Personal Development</u>

Membership: The committee will comprise of 6 (six) governors, one of whom shall be the Headteacher.

The membership and Terms of Reference of the Committee shall be reviewed annually. The quorum will be 3 (three) Governors.

Terms of Reference

To monitor the progress of the school and Governing Body against the Behaviour and Attitudes and Personal Development sections of School Improvement Plan.

To ensure that policies and procedures are in place to reduce barriers to learning, improve behaviour, attendance and punctuality and reduce exclusions. Statutory policies include:

- SEN Policy
- Schools GDPR Data protection Policy
- Behaviour Policy
- Online safety Policy
- Acceptable Use Policy Inc Staff, governors and volunteers, Pupils KS1, Parents, Visitors and contractors and Pupil KS2.

To monitor key performance indicators for behaviour and welfare (rates of exclusions, attendance levels and rates of persistent absenteeism) and provide support and challenge for the Headteacher and school leaders in improving and/or maintaining high standards in these areas.

To ensure that policies and procedures are in place to promote the spiritual, moral, social, and cultural development of children and that the school successfully promotes fundamental British values

Pupil KS2.

To ensure that policies and procedures are in place to keep pupils in the school safe, including policies and procedures linked to bullying, exploitation and staying safe online

To review the policy and provision for Collective Worship and for Religious Education and provide support and challenge for the Headteacher and school leaders in ensuring the school's distinctiveness and effectiveness as a church school

To review the policy and provision for Sex Education and make recommendations.

To ensure that the requirements of children identified on the register of Special Educational Needs are met. It shall have a special responsibility to monitor equality and inclusion (as set out in the Equality Act 2010) that is regardless of race, disability, religion, or gender; and with particular reference to the treatment of emotional, pastoral as well as educational needs of children in care, refugees and asylum seekers or on the child protection register.
